Standing, Special, and Ad Hoc Committee reports:

- Education (CB): Issues continue surrounding the CTU, teachers, schools, and pandemic-related troubles. Chair to have a meeting with Pullman Elementary regarding current status on Feb. 18
- Safety (CL): Carjackings are on the rise info learned from recent meetings with CPD on the topic are included in Committee's Flyer article this month. Takeaway from last night's Beat meeting is that Beat 531 has the lowest crime in the district, and the most number of calls ergo, residents are encouraged to continue calling in activity, in order to keep the crime rate low. - Nominating (RS): President to reach out to potentially interested members to serve
- Vision (BB): Committee is embarking on Road Safety measures, in conjunction with Community Improvement Committee. Committee is

currently addressing truck traffic concerns in the neighborhood via outreach to local businesses that use trucks, as well as GPS services. Members are encouraged to recommend any such businesses and/or GPS services to the Chair, and are further encouraged to visit gps.gov to provide additional feedback. Efforts to increase inclusivity in Pullman are in the works.
